

# Knights of Columbus 2020 Trip of the Month - Rules and Regulations

1. Total prize value is \$34,440.00.
2. Only 400 tickets sold at \$120 each.
3. Tickets can only be sold/purchased in Saskatchewan.
4. 2 Draws will be made on the 3rd Monday of each month at the Knights of Columbus Council Chambers, 1102, 3rd Ave NW at 7:15PM: 1) Trip of the month; 2) \$120.00 prize
5. Tickets are represented by assigned numbered plastic discs (the number of your ticket) and picked out of a mixing barrel by someone who does not have a ticket.
6. Winners will be announce on Facebook, by e-mail to those who purchased a ticket and who have an e-mail address and by telephone.
7. Prizes are transferable only prior to booking with Vision Travel Regina – through Terry Kaszas, CTC, Regional Manager, the booking agent.
8. Trips must be booked through Vision Travel and Terry Kaszas the booking agent within 6 months of draw date. Based on availability, - Christmas / Easter / Holiday Periods are excluded. Winner must decide within 1 month of draw date to take designated trip, or a trip voucher worth **75%** of the trip value, or a cash payment of **50%** of the trip value.
